Please be advised that I must amend the N.J. Division of Local Government Services, Emergency Procurement Report dated November 15, 2010 for Hudson Hall.

The reason for the amendment is that costs were increased for the following reasons:

- Additional equipment was required to be replaced at the job site that was thought to be in good working order but subsequently was determined to be unsalvageable and thus an additional cost of \$13,872. Powerpoint Electric Company is required. These costs have been reviewed and approved by the Town Engineer.
- 2. For the reasons of public safety the Bureau of Fire Safety determined that based on conditions that were not foreseen at the time of the original declaration of emergency and approval of same, that the extended use of the services of a fire watch in order to protect the building occupants and surrounding neighborhood was required. The additional cost for Cambridge Security is \$15,574.70.

The foregoing Ordinance was adopted on first reading by the Mayor and Board of Commissioners of the Town of West New York, New Jersey on January 19, 2011 and ordered published, and will be further considered before final passage at a public hearing on February 10, 2011 at 7:00 p.m. at the Court Chambers, Municipal Building, West New York, New Jersey. A copy of this ordinance has been posted on the bulletin board upon which public notices are customarily posted on in the Town Hall of the Town of West New York, and a copy (at no charge) is available up to and including the time of such meeting to the members of the public of the Town who shall request such copies, at the Office of the Town Clerk in said Town Hall in West New York, New Jersey.

Note: Town Clerk Carmela Riccie read the foregoing Notice aloud.

Note: Mayor Vega inquired as to whether there is any other business. Town Clerk Riccie responded, "Not to my knowledge."

Mayor Vega announced that there is a five (5) minutes limit for each speaker, and that no one be allowed to speak more than once. In addition, he requested that everyone be courteous to fellow audience members.

Mayor opened the Public Portion.

Public Portion:

1. Dr. Count Wiley, 6010 Monroe Place, WNY:

Dr. Wiley inquired as to the purpose of Bond Ordinance #1/11. Town Administrator McConnell advised that it relates to paving of streets, park improvements, etc. and that most of the funds will be reimbursed to the Town at the State level. Dr. Wiley commented that he was under the impression that the Town was ceasing from bonding any more funds. Mayor Vega explained that when grant monies are received from the State Dept. of Transportation, we must perform the work first and when work is completed the Town receives reimbursement. Dr. Wiley inquired as to how much reimbursement will be received, to which the Mayor responded "80%". Dr. Wiley stated that money should be expended on hiring additional police officers and not on repaving more streets. Dr. Wiley commented about the school system and students' grades in West New York are not as high as in surrounding communities such as North Bergen. He advised that North Bergen's school system had been recently nominated for the Blue Ribbon Award. He inquired as to why the West New York school system is not at the same level as North Bergen. Comm. Lopez disagreed and defended the West New York Board of Education. Mayor Vega commented that he is proud of our school system and that the teachers work very hard. Dr. Wiley commented about the sale of the D.P.W. Garage for \$8 million to the County. Mayor Vega explained that said sale occurred as a result of the financial situation which existed at that time, but that we have a much better financial standing now than we had four years ago.

2. <u>Dr. Felix Roque, 5711 Jefferson Street, WNY:</u>

Dr. Roque commented that if the Town is attempting to save money, each Commissioner should relinquish his or her vehicle. He complained that Comm. Riccardi uses his vehicle to travel to his summerhouse, that Comm. Lange uses his vehicle for personal reasons and that the Mayor uses his vehicle to go to restaurants. He recommended that use of vehicles should be curtailed and/or a \$50.00 gas stipend should be implemented. Mayor Vega explained that under this form of government, Commissioners are on call 24 hours per day 7 days per week. The Mayor further advised that each Commissioner forfeited his or her right to health insurance coverage through the Town thereby saving the Town money. Dr. Roque inquired as to how many auto accidents the Mayor has had with his Town vehicle to which the Mayor responded "I don't remember". Dr. Roque commented that he would bring a copy of all the police accident reports with him to the next Commission meeting. Dr. Roque commented about Comm. Lange's recent auto accident. Mayor Vega advised that inasmuch as Comm. Lange is entitled to his day in court, he would not comment. Dr. Roque suggested that Comm. Lange should relinquish his vehicle and that if the same circumstances had occurred involving someone else, that person would have been arrested for leaving the scene. Dr. Roque complained about the amount of time it took to remove the snow especially on 60th Street. Mayor Vega commented that he personally received numerous compliments for handling of snow removal. Comm. Rodriguez joined conversation and advised that snow was hauled away on 60th Street and that he was proud of the outcome. Dr. Roque indicated that he had received several letters from people complaining about the snow removal. Mayor advised him to present said letters to the Town Clerk. Dr. Roque commented about the Mayor's salary of \$146,000 as Director of Athletics.

3. Alina Waxman, 20 Avenue at Port Imperial, WNY:

Mrs. Waxman indicated that there are many residents from Port Imperial present at tonight's meeting and inquired as to how the Town could grant a "restaurant/night club" a permit to open in residential building. She complained that the music emanating from Son Cubano at 2:30 a.m. is keeping people awake. She inquired "Did you grant a cabaret license or club license?" Mayor Vega explained that when the waterfront development began 15 years ago, the vision of the developer was to create residential and commercial space and that the space in question was for the purpose of attracting a restaurant. Mrs. Waxman responded "It is a Night club, not a restaurant". She advised that there have been altercations outside the establishment and that on Sunday she witnessed "a man beating a

half naked girl". She also advised that she had contacted the developer, Roseland, to add a kid friendly location but was told that they do not think this is correct community for kid friendly environment. She commented about the Mayor frequenting Son Cubano Restaurant. Mayor Vega advised that he attended the Grand Opening on December 16th and had dinner there last Saturday but left at 11:00 p.m. She claimed she had video footage of Mayor's appearances at Son Cubano, which she intended to post. Mayor Vega advised that the Town Attorney has met with interested parties regarding noise complaints in an effort to negotiate a resolution. Mrs. Waxman commented that there is no room for negotiations to permit a nightclub. She complained about snow removal and noise from shovels removing snow in her development. Mayor Vega advised her inasmuch as her development is private property, that snow removal is done by a private firm, not by Town employees. Mrs. Waxman inquired "Do you want the residents to leave?" Mayor responded "We want more to come". She replied "Then stop the nightclub".

4. Warren Wilhide, 20 Avenue at Port Imperial, WNY:

Mr. Wilhide complimented the area in which he residents as it relates to business establishments which have opened i.e. Starbucks, etc. He indicated that he frequented the sister restaurant of Son Cubano in New York, which he enjoyed very much, however, he complained that such a restaurant should not be operating in a residential area on the waterfront. He further indicated that eight (8) months prior to Son Cubano opening, he wrote a letter to the Mayor outlining his concerns. He complained that the Mayor "ignored" his letter, and expressed his concerns about this establishment becoming a nightclub. Mayor Vega advised that he did not ignore his letter, but that he directed the Town Attorney to address the issues. Mr. Wilhide advised that Roseland assured him in writing that this restaurant would not be a nightclub. Mr. Wilhide referred to the establishment as a "Trojan horse", and that the vibration from music is unacceptable in a residential area. He commented that the lease should be re-negotiated to prohibit live music. Mr. Wilhide inquired "Should we secede from the Town of West New York and become our own Town?" Mayor Vega commented that a compromise is warranted. Mr. Wilhide advised that every month the residents will be present at Commission Meetings until this problem is resolved. He alleged that inasmuch as the Mayor is a personal friend of the owner of Son Cubano, that preferential treatment was given. Mayor vehemently denied same explaining that he grew up with a member of the family but that had no bearing on the matter. Mayor Vega stated "They don't need me. They have done very well without me". Mr. Wilhide complemented the efforts of Town Attorney Horgan but stated "A compromise will not do". Mayor Vega thanked him for bringing this matter to his attention.

At 7:40 p.m. a motion was made by Commissioner Riccardi, seconded by Commissioner Lopez to close the public portion and adjourn the meeting was carried by the following vote:
