Note:

Mayor Vega recognized the Boy Scout Troup present tonight, which is celebrating their $100^{\rm th}$ Anniversary. Mayor stated, "Thank you for your services to our community, the State and our Nation."

Mayor Vega inquired as to whether there is any other business. Town Clerk Riccie responded, "Not to my knowledge."

Mayor Vega reminded all in attendance of the five (5) minute rule.

Mayor opened the Public Portion.

Public Portion:

1. <u>Diana Diaz, 6601 Park Avenue, WNY</u>:

Ms. Diaz inquired as to the number of incidents, i.e. rapes, assaults, etc. which have occurred in West New York during the month of October. She indicated that she heard the number was "27". Mayor Vega responded "To make sure you get the correct information, the Police Director will contact you directly with the precise figures." Ms. Diaz advised that her father, who lives on 64th and Hudson Avenue, comes home from work at 5:00 a.m. and that the area in which he lives is "gang infested", and that several of his neighbors have been assaulted. She further commented that there is a lack of police presence. Mayor Vega thanked her for bringing this to his attention and to the attention of the Police Director who is also present. Ms. Diaz also wished to know the number of assaults which have taken place for the year 2010.

Public Portion (Cont.):

2. Clara Brito-Herrera, 6312 Jackson Street, WNY:

Ms. Brito-Herrera agreed with the comments made by Diana Diaz and indicated that the information provided by the Police Director should be made public by publishing it in the local newspaper. Mayor Vega advised that "This week, the State Police released statistics that crime is down 16% in West New York over last year." Ms. Brito-Herrera responded "I want to know the amount of crimes since September to today as a concerned citizen and Principal of #1 School. It should not be made available by phone call only to her. It should be a service to the community. Many people are equally concerned." Mayor Vega advised that if anyone else wished to receive this information, they should place their request in writing to the Town Clerk.

3. Linda Dieguez, 6505 Hudson Avenue, WNY:

Ms. Dieguez inquired as to whether the Commissioners have any intention to implement a curfew like the one which was in place when she was a high school student. She complained about 15-16 year old young adults intoxicated congregating on Hudson Avenue late at night. Mayor Vega acknowledged her concerns and advised that a new curfew regulation has been established which meets the guidelines of State law. Town Attorney Horgan explained that the Town adopted a curfew regulation which the Police Dept. can now enforce. He encouraged her to notify the Police hotline on the Town's website if future incidents should occur. Ms. Dieguez commented that her calls to the Police Dept. "are ignored". She advised of a recent incident wherein her husband's car was repeatedly struck by a baseball, causing the car alarm to sound, however, no police responded despite repeated calls to the Police Dept. Mayor Vega explained that the Police Dept. responds to incidents based upon priority at that given moment, which is challenging, but that he feels the Police Dept. is doing an excellent job under the circumstances. Comm. Lange advised of a situation wherein he had occasion to contact the Police Dept. to complain about groups of teenagers on skateboards late at night, but did not identify himself in order to determine whether a timely response would be forthcoming. He indicated that his experience with police response has been "very good". Mayor Vega thanked Ms. Dieguez for her comments.

4. Dr. Felix Roque, 5711 Jefferson Street, WNY:

Dr. Roque referred to Ms. Dieguez's concerns and the issue of laying off 22 police officers last year, and commented "Can you imagine what would have happened?" Mayor Vega replied "It never happened. We hired four (4) police officers. We saved \$1 million by negotiating with the employees' union, balanced the budget and no police officer was laid off. You didn't help us. You made us spend \$100,000 for a bogus recall." Dr. Roque inquired as to whether the Mayor had contacted "Onel" regarding the incident which occurred on 64th and Park Avenue and as to how many days had elapsed from the time incident occurred and the Mayor's contact, to which the Mayor responded "Yes I did. I did show my concern." Dr. Roque recommended that the Mayor be "more concerned about the people of West New York". Dr. Roque complained about a recently circulated flyer which contained Dr. Roque's cell phone number and inquired as to whether the Mayor was taking responsibility for it. He commented that inasmuch as he is a physician, "it is disrespectful and in bad taste" to publicize his cell phone number. Conversation ensued regarding recent lawsuits filed by Dr. Roque against the Mayor and Commissioners and allegations of fraud, which Dr. Roque vehemently denied. Comm. Lange joined conversation and comments were made by Dr. Roque regarding incident which allegedly occurred between Comm. Lange and his wife. Dr. Roque stated "You broke your wife's nose". Comm. Lange denied the allegation and responded "You stole \$2,200 from my neighbor. You are a piece of garbage because you steal." Discussion ensued between Dr. Roque, Mayor Vega and Comm. Lange regarding access of Comm. Lange's wife's medical records. Mayor inquired as to whether Dr. Roque has access to said records. Dr. Roque commented that he has access to things like the Mayor has access to things. (At this point, numerous people were speaking at the same time and meeting was out of control.) Mayor advised Dr. Roque that his time to address the Board of Commissioners had expired. Dr. Roque inquired as to how much the Mayor earns in his position as Athletic Director and how often does he

appear at his place of employment. Mayor Vega responded "Every day". Discussion ensued between Dr. Roque and Comm. Lange. Comm. Lange referred to Dr. Roque as "stupid". Dr. Roque replied "I am a Doctor, you are nothing". Diana Diaz stepped forward to say "You shouldn't call anybody from your Town stupid". Dr. Roque complained that there are only 3-4 police officers covering the Town and inquired as to what the Mayor intends to do about this situation. Mayor responded "Where are you getting this information?" Dr. Roque replied "From Police Officers".

At 7:25 p.m. a motion was made by Commissioner Rodriguez, seconded by Commissioner Lopez to close the public portion and adjourn the meeting was carried by the following vote:
