PUBLIC NOTICE

TAKE NOTICE that the undersigned shall expose for sale in accordance with R.S. 39:10A-1, at PUBLIC AUCTION on:

June 7, 2010

at **11:00 a.m.**, at the **Municipal Building - Court Chambers, 428 - 60th Street, West New York, New Jersey**, the automobiles set forth herein which came into possession of the Police Department as a result of abandonment by the owners thereof:

Two (2) hours prior to auction the Police Department will make available transportation to various locations where the automobiles to be auctioned can be inspected. Minimum bid will be **\$50.00** for Junk Title Certificate for each vehicle. **There will be no storage fee charged.**

The successful purchaser or purchasers shall pay the full amount of cash or certified check payable to the Town of West New York at the time of the sale. The purchaser or purchasers shall remove the vehicles from their present location within 48 hours of approval of bids by the Board of Commissioners.

Sale will be on an "as is" basis without warranty or guarantee whatsoever. Minimum bid will be **\$50.00** per each vehicle, plus \$2.00 for Junk Title Certificate for each vehicle.

Sale will be conducted on a bulk bid basis covering all vehicles to be sold.

No individual bids will be accepted.

The purchaser or purchasers shall, in addition to the amount of the bids, pay any fees that may be required by the Department of Motor Vehicles of the State of New Jersey for the transfer of title of these vehicles.

The Board of Commissioners shall have the right to reject any and all bids upon submission of same to the undersigned. In the event said Board of Commissioners exercises said power, the undersigned shall adjourn said sale to a date no later than two weeks from the date fixed herein.

Upon the date of delivery of vehicle to the purchaser, the transfer of title, the titling of the vehicle in the purchaser's name, or registration of vehicle in purchaser's name with the Motor Vehicle Commission or other governmental agency, whichever occurs earlier, risk or loss or damage to property by fire, storm, burglary, vandalism or other casualty shall be assumed by the purchaser, who shall be completely responsible therefore without any claim against the Town. The purchaser shall not be released, by reason of any such loss or damage to the property from any obligation hereunder and shall at his own expense properly repair and restore the same. Without limiting the obligation of the purchaser hereunder, the proceeds of any insurance coverage provided by the purchaser shall be made available to the purchaser for such repair or restoration.

Further from the time of auction, the purchaser shall release the Town (including its agents, officials, officers, employees, and assigns, collectively "Town") from any loss or damage to property, or injury to or death of, any person occurring, on or about or resulting from, any defect in the property to be conveyed, or arising from any act or omission on the part of the Town or Purchaser, and agrees that the to indemnify and hold the Town harmless against, any loss or damage to property, or injury to or death of, any person occurring on or about or resulting from, any defect in the property to be conveyed, arising from any act or omission on the part of the Town or Purchaser.
