ORDINANCE NO. 5/11

**AN ORDINANCE EXPANDING THE MEMBERSHIP OF
THE BOARD OF EDUCATION**

WHEREAS, at the present time the Board of Education consists of five members appointed by the Mayor; and

WHEREAS, the Governing Body wishes to broaden the number and quality of the membership of the Board to best serve the education for the residents of the Town of West New York; and

WHEREAS, this action is authorized by N.J.S.A. 18A:12-6,

NOW THEREFORE BE IT ORDAINED by the Board of Commissioners of the Town of West New York as follows:

Section 1. The members of the Board of Education of the Town of West New York shall consist of seven (7) members.

Section 2. Each member shall be appointed by the Mayor.

Section 3. Terms

All members of the seven (7) man appointed Board shall be in accordance with N.J.S.A. 18A:2-9.

Section 4. Inconsistent Ordinances Repealed

All Ordinances inconsistent with the provisions of this Ordinance are hereby repealed as to such inconsistencies only.

Section 5. Effect of Partial Invalidity

If any provisions of this Ordinance are found to be invalid, for any reason, by the final judgment of a Court of competent jurisdiction, the validity of such portions shall not affect the validity of the remaining provisions of this Ordinance, which shall be severable therefrom.

Section 6. Effective Date

This Ordinance shall take effect immediately upon final passage and publication as required by law.
