





Lester Gonzalez Penton Nació en el poblado de Encrucijada, provincia de Villa Clara, día 22 de febrero de 1977. Hijo de Alberto González y Mireya Pentón. Comienza su vida laboral a los 17 años como sereno en un Quiosco en las áreas exteriores del stadium de pelota. En el año 1998 comienza como activista en el Partido Pro Derechos Humanos afiliado a la Fundación Andrei Sajarov, donde conoce el acoso de los órganos represivos del régimen, mas tarde comienza Confederación de Trabajadores Democráticos, siendo su delegado provincial. Ya en el 2002 en compañía de Pedro Castellanos y Eloína Díaz Ruiz, funda el Movimiento Democracia. Ya estando en Democracia es el organizador del ayuno por la detención de Juan Carlos González Leiva, donde es acosado fuertemente por la policía política, siendo citado donde se le impone una medida cautelar. Por motivos personales abandona Democracia, y funda junto a Pablo Solís Cubilla el Movimiento Alfa 3, siendo vice presidente del mismo.

Posteriormente decide abandonar Alfa 3, para dedicarse al periodismo Independiente, para mantener informada a la opinión pública de la actualidad cubana. En estas funciones es detenido el 18 de marzo de 2003, encausado injustamente y sancionado a 20 años de privación de libertad. En su trayectoria como opositor siempre denunció las violaciones de la Declaración Universal de los Derechos Humanos. En una ocasión se personó en el Partido Comunista provincial de Villa Clara., a reclamar por el desalojo de una persona de la raza negra, siendo fuertemente reprimido y conducido a la policía, imponiéndole una multa. Activista del Movimiento pro Derechos Humanos Razón, Verdad y Libertad. Lester Gonzalez Penton fue desterrado a España el 13 de Julio del 2010 contra su voluntad. Y hoy reside en Los Estados Unidos de America.

Whereas, Dr. Biscet "continued to call for non-violence, and has called forth the memory of personal heroes such as Mahatma Gandhi and Martin Luther King, Jr."

1. Yesenia Camilo, 330 – 50th Street, WNY:

Ms. Camilo requested that residential parking apply to the entire Town in that the area in which she lives has been “bombarded by new businesses” taking parking spaces, and that people taking the train also park there. Mayor Roque acknowledged that it is an obligation to work with the community, and requested that she send a letter to him outlining the issues. He advised that he is working with the Parking Authority to issue summonses to non WNY residents and that metered parking will stop at 6 p.m. He further requested that she meet with him after the conclusion of today’s meeting to discuss this matter. Comm. Wiley inquired as to whether there are a lot of commercial vehicles parking in her area to which she replied “Yes”. Comm. Wiley also expressed his desire to speak to her after the meeting.

Public Portion (Cont.):

2. Marcel Hart, 5504 Grant Place, WNY:

He complained that the street sign at corner of 56th Street and Grant Place has been missing for three (3) years and requested that it be replaced. He commented that with reference to the Board of Education, he has never seen “such hard headed people trying to hold onto appointed positions” and that those persons should have resigned upon the election of the new Administration. He commented that the Superintendent of Schools has been “silent” on this issue, that the Board President is “a bully”. He inquired as to the time line to replace board members, Passante and Locatelli. Mayor Roque suggested that Mr. Hart call him on his cell phone whenever he has any problems. Comm. Wiley advised that he would take care of replacing the sign. Mayor Roque requested Asst. Town Attorney DeMarco to explain the current legal issues involving the Board of Education and stated “When I took office my goal is to have the teachers teach and that there is no politics in the schools”. He referred to his own education which afforded him the opportunity to become a doctor and a military man. Mr. DeMarco advised that a challenge was filed with the Director of Education who referred the matter to the Administrative Law Judge, who ruled on Monday that the appointments of Janet Passante and Alex Locatelli were invalid and political in nature and his recommendation is clear; that they should be removed immediately. He further explained that there is a 13-day window for clarification of the Order, and that the Commissioner of Education has been advised that there is a meeting tonight requiring actions on contracts, etc. He also asked the Board to adjourn tonight’s meeting for two (2) weeks to allow for the receipt of the Commissioners’ ruling but that his request “fell on deaf ears”. The meeting will proceed tonight despite his request but that any action taken is subject to question by the new Board. He advised that he is confident that the Commissioner will agree. He further advised that the attorney representing board members Passante and Locatelli has a bill of \$25,000. Mr. Hart complained that there is no heat in his classroom at School #5 and that the \$25,000 could be spent for more important things. He again commented “What are they hiding and trying to protect? Why don’t they step down?” Mayor Roque responded “We believe in transparency and if there is corruption there, we will get to the bottom of it. If there is, they will be arrested.”

2. Matthew Cheng, 6124 Madison Street, WNY:

Mr. Cheng inquired about the payment made to settle the lawsuit regarding form Chief Financial Officer. Asst. Town Attorney DeMarco advised that he did not have the exact figure but that he would provide Mr. Cheng with the information. Mayor Roque inquired as to whether Mr. Cheng filed an OPRA request for said information to which Mr. Cheng replied “No”. Town Administrator McConnell explained that the payment was made through the JIF (Joint Insurance Fund) and that there had been an OPRA filed with JIF. Mr. Cheng briefly commented about the Town’s revenues and bills. Mr. McConnell advised him to meet with John Mosca so that he could give him a full explanation of the budget process. Mr. Cheng inquired as to whether the municipal employees’ union raises had gone into effect to which the Mayor explained that raises were being postponed as he had no intention of raising taxes. Mr. DeMarco explained that this year’s budget had been previously adopted and that the concerns are with next year’s budget, and that the raises would affect next year’s budget. Mr. DeMarco also pointed out the Mr. Cheng was inadvertently mixing two (2) budget years together. Mr. Cheng inquired about the Code Official and Deputy Mayor who had both been placed on administrative leave. Mr. DeMarco confirmed said fact but explained that it deals with personnel issues which cannot be discussed by the governing body without prior notice given to both individuals. Mr. Cheng inquired as to whether they were being paid while on leave to which Mr. DeMarco advised that they are being paid.

3. Salih Delky, 111 – 63rd Street, WNY:

Mr. Delky advised that he owns a restaurant at 5122 Kennedy Blvd. and that Mr. O’Malley closed his restaurant for “no reason”. Mayor Roque inquired as to when it was closed. Mr. Delky responded June 9 or 10. Mayor Roque advised that he could not discuss personnel matters as the person in question is under administrative leave and the department is under investigation. He requested that Mr. Delky put his complaints in writing and send it to the Town Attorney. Mr. Delky indicated that he would do so.

4. William Guerrero, 6008 Tyler Place, WNY:

Mr. Guerrero commented that he has been complaining for many years about his neighbors at 6006 Tyler Place for operating an illegal kennel. He commented that he had appeared before the governing body last month and pleaded for help, and three (3) days later, the Animal Control Officer removed 37 cats from the above location. However, 12 cats and 7 dogs remain. He further commented that he has complained about the smell, barking, etc. and that the animals are not being cared for. He advised that the neighbor has been found guilty of having a kennel, but that the Health Officer advised him last week that he refused to accept any further complaints from him and that no further inspections will be made. Mayor Roque pointed out that although he alleges making complaints for past several years which Mr. Guerrero insists still persist, that within a short period time of taking office, he (Mayor Roque) has sent the Inspector to the location and action was taken. Mr. Guerrero inquired as to why the Health Officer refuses to take future complaints as problems still exist. Mayor Roque responded "I sense your frustration. I have been following through and will continue to do so". Asst. Town Attorney DeMarco explained that as a result of court case, Judge ruled that neighbor is subject to future visits by the Animal Control Officer for the next six (6) months (once per month). Mr. Guerrero complained that additional animals are being brought into the premises. Discussion ensued with Comm. Frias and Mayor regarding the 37 cats already removed and how many pets remain. Mr. Guerrero also commented that neighbor feeds the squirrels and pigeons, which is prohibited. Mayor Roque advised that he would contact the Inspector again, that things are being done and that he is trying to help him. Comm. Rodriguez explained that the Town cannot continue to send additional inspectors within the aforementioned six (6) month period as it must abide by court order. Comm. Rodriguez further commented that the Judge ruled that remaining pets can stay. Mayor Roque advised that he would request the Health Officer to meet with him and requested his patience.

5. Angela Dubal, 316 – 55th Street, WNY:

Ms. Dubal recommended that the Town purchase a new microphone system. She further commented that while the meeting is in progress, that it is rude for some audience members to be talking as other persons present are interested in WNY and wish to hear what is being said, and that the Mayor deserves that respect. Mayor agreed with her and stated "We are all professionals here".

6. Clara Brito-Herrera, 6312 Jackson Street, WNY:

She commended Comm. Wiley for doing a great in her neighborhood with garbage removal, etc. and recommended that dog waste bags be placed specifically near School #1 as it is an ongoing problem. Discussion ensued between Ms. Brito-Herrera and Comm. Wiley regarding said issue. She thanked the Mayor for continuing his goal for "transparency" at the Board of Education. She complained about pending transfers of Asst. Principals from School #1 and that the schools are not ready to open in September. She advised that additional people are intended to be hired at tonight's Board of Education meeting and urged everyone to attend the meeting as decisions are being made "which are not in the best interest of education". Mayor Roque agreed and commented that there are "political hacks not educators teaching our children". He advised that any decisions made tonight would be voided.

7. Ron Scheurle, 6119 Tyler Place, WNY:

Mr. Scheurle stated "Times are bad and a lot of people are out of work in West New York yet your Administration hired 4-7 people who are not from West New York but are from other Towns. We have plenty of West New York people." He commented that there is a residency ordinance in effect and inquired why it is not being enforced. Mayor requested him to provide him with the names of said employees and that he would meet with him regarding said issue.

8. Dania Concepcion, 154 – 59th Street, WNY:

Ms. Concepcion thanked the governing body for “104 days of change” and stated “We believe in you”. Mayor agreed and stated “Lead by example”. He thanked his Commissioners, John Pinto, and the Police Department for their cooperation. He commented that real arrests are being made not make believe arrests as claimed by the prior Administration. He advised that West New York has a bright future, that “Formula I” racing is coming to Town and West New York will be recognized worldwide. He commented that the Mayor of Weehawken has been giving him a lot of help but it is not an easy process. Mayor stated “We do care. I care for this community. I wanted to fight to do the right thing. I love to fight. We are here to do the right thing. Feel free to contact me on my cell. I do this from the heart as a human being, not as a politician.” He requested participation from everyone to work together to make West New York better. He stated “Together we can make this Town the best. I am hoping to lower the taxes.” Comm. Wiley expressed his personal feelings and thanked everyone for electing him stating “It is an honor and pleasure to serve you”.

9. Lelin Jimenez, 5607 Hudson Avenue, WNY:

Ms. Jimenez spoke Spanish solely. Mayor Roque translated that she is very proud of the governing body; that the streets are clean, her block is secure and she is very happy.

10. Rafael Cruz, 527 – 61st Street, WNY:

Mr. Cruz commented that there are “no more puppets” on the Board of Commissioners, and that this Administration is trying to do good for the community. He referred to tonight’s Board of Education meeting and inquired as to whether the public will be permitted to speak. Mayor advised that he will be present at the meeting and will place his objections on the record but recommended the attendees conduct themselves in a proper manner.

11. Maria Dones, 200 – 49th Street, Union City:

Ms. Dones spoke Spanish solely. Mayor Roque translated that she is complaining that the taxpayers pay when parades are held in WNY, which could cost from \$8,000-\$10,000 per parade and that is not right during this time of financial crisis. She also complained about the numerous newspaper racks on the streets, which she claims are not maintained and cause damage to the sidewalk. Mayor Roque advised that he would look into the matter.

The letter is inaccurate factually as the Municipal Administrator admitted that he has submitted no documents to Mr. Horgan and had no information whatsoever concerning the appropriateness of this Agreement; and

WHEREAS, an agreement dated April 30, 2010 was signed by the Municipal Administrator authorizing the payment of \$306,324.30 to Janet Passante for accrued 172 days of vacation time, 300.5 sick days and 1366 compensatory hours. The contract provides that she will be paid the sum of \$10,201.81 per month without interest. Payments to commence on July 15, 2010, August 16, 2010, February 15, 2011 and August 15, 2011 and the balance due on August 15, 2012; and

WHEREAS, an agreement was entered into by the Municipal Administrator and Ray Casper to pay him the sum of \$116,521.12 payable at \$2,427.52 per month for 118 days of vacation and 219 days of sick time,

NOW THEREFORE BE IT RESOVLED by the Governing Body that based upon this investigation the Governing Body finds that there was no basis contractually or past policy to pay these termination payments to either Janet Passante or Raymond Casper and the payment that were made and to be made are ultra vires and void and are essentially a gift for past already compensated services; and

BE IT FURTHER RESOLVED that Special Counsel is authorized to take such steps as he deems necessary and appropriate under the law to return to the Town payments previously made and to cancel all future payments under the alleged and improper contracts; and

BE IT FURTHER RESOLVED that Special Counsel is authorized to cooperate fully with any State investigatory agency and to turn over to that agency any and all information; and

BE IT FURTHER RESOLVED that the resolution dated August 18, 2010 ratifying and approving the payment of past employee benefits to Raymond Casper is hereby rescinded; and

BE IT FURTHER RESOLVED that the resolution dated May 10, 2010 ratifying and approving the payment of past employee benefits to Janet Passante is hereby rescinded.
