

**TOWN OF WEST NEW YORK, COUNTY OF HUDSON**

**ORDINANCE #10/16**

**AN ORDINANCE AMENDING CHAPTER 127 OF THE CODE OF THE TOWN OF WEST NEW YORK ENTITLED “BARBERSHOPS”**

**WHEREAS**, Chapter 127 of the Code (the “Code”) of the Town of West New York (the “Town”) regulates barbershops; and

**WHEREAS**, the Town seeks to clarify what is included in barbershops and the licensing fee for same; and

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Board of Commissioners of the Town of West New York that Chapter 127 entitled “Barbershops” shall be amended as follows:

**Section One**

The following definition shall be deleted:

BEAUTY SALON- Any place wherein any person, firm or corporation represents to the public that the person, firm or corporation is engaged in the occupation or business of waxing, clipping, cutting, dyeing, shampooing or trimming of hair and/or massaging of the faces or scalps of the patrons thereof.

The following shall be substituted therefor;

BEAUTY SALON- Any place wherein any person, firm or corporation represents to the public that the person, firm or corporation is engaged in the occupation or business of waxing, clipping, cutting, dyeing, shampooing, threading or trimming of hair and/or massaging of the faces or scalps of the patrons thereof.

**Section Two**

Section 127-2 entitled “License required; application procedure; term of license; restrictions on location” shall be amended to delete the following paragraph:

D. Any person who shaves, clips, cuts, shampoos or trims hair and/or massages faces or scalps in a barbershop; and person who clips, cuts, shampoos, or trims hair and/or massages faces or scalps in a beauty salon; any person who clips and/or styles nails of hands and feet in a nail salon shall apply for a license on an annual basis and the fee for said license shall be \$25.

The following shall be substituted therefor:

D. Any person who shaves, clips, cuts, shampoos or trims hair and/or massages faces or scalps in a barbershop; any person who waxes, clips, cuts, dyes, shampoos, threads or trims hair and/or massages faces or scalps in a beauty salon; any person who clips and/or styles nails of the hands or feet in a nail salon shall apply for a license on an annual basis, and the fee for said license shall be \$50.

#### **Section Four**

**Severability.** The provisions of this Ordinance are declared to be severable and if any section, subsection, sentence, clause or phrase thereof for any reason be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, subsections, sentences, clauses and phrases of this Ordinance, but shall remaining in effect; it being the legislative intent that this Ordinance shall stand notwithstanding the invalidity of any part.

#### **Section Five**

**Repealer.** All ordinances or portions thereof in conflict or inconsistent with this Ordinance are hereby repealed, but only however, or the extent of such conflict or inconsistency, it being legislative intent that all ordinances or portions of ordinances now existing or in effect shall remain in effect unless the they are in conflict or inconsistent with any provision of this Ordinance.

#### **Section Six**

**When Effective.** This ordinance shall take effect upon passage and publication as required by law.

## SUMMARY OF ORDINANCE

This Ordinance amends Chapter 127 to add threading services as included within the definition of beauty salon and that the license fees for barbershops, beauty salons and nail salons shall be \$50.
