ORDINANCE NO. 14/11

**AN ORDINANCE TO AMEND ORDINANCE NOS.
1053, 43/94, 17/96, 4/97, 3/98, 4/99, 8/99, 6/00, 3/01, 2/02, 1/03 and 1/05
ENTITLED "LIQUOR LICENSE FEES"
ALSO BEING SECTION 114-19 & 114-20 OF THE
CODE OF THE TOWN OF WEST NEW YORK**

WHEREAS, P.L. 2003 c. 117 amended N.J.S.A. 33:1-12, which increased the maximum fees for certain alcoholic beverage licenses as follows:

Plenary Retail Consumption: new minimum \$250.00; new maximum \$2,500.00
Plenary Retail Distribution: new minimum \$125.00; new maximum \$2,500.00
Limited Retail Distribution: new minimum \$31.00; new maximum \$63.00
Club licenses: new minimum \$63.00; new maximum \$188.00 and;

WHEREAS, it is in the best interest of the Town of West New York to increase said fees in compliance with the limits established by the State of New Jersey Alcoholic Beverage Commission and in accordance with N.J.S.A. 33:1-12 as amended; and

NOW, THEREFORE BE IT ORDAINED by the Mayor and Board of Commissioners of the Town of West New York that Ordinance Nos. 1053, 43/94 17/96, 4/97, 3/98, 4/99, 8/99, 6/00, 3/01, 2/02, 1/03 and 1/05 be and the same hereby are amended to delete existing sections 114-19 and 114-20 of the Code Book and replace those two sections, as follows:

Section 114-19 License Fees

The License fees for Alcoholic Beverage Licenses in the Town of West New York, New Jersey, shall be as follows:

- A. Plenary Retail Consumption License; Two thousand five hundred dollars per annum (\$2,500.00)
- B. Plenary Retail Distribution License; Two thousand five hundred dollars per annum (\$2,500.00)
- C. Limited Retail Distribution License; sixty-three dollars per annum (\$63.00)
- D. Club License; one hundred eighty-eight dollars per annum (\$188.00)

Section 114-20 Incremental Increases in Fees

The above license fees shall take effect as permitted by P.L. 2003 c. 117, which amended N.J.S.A. 33:1-12, increasing present fees for the above referred to licenses until the maximum amounts for those levels are reached. Said increases do not exceed 20% per annum.

AND BE IT FURTHER ORDAINED by the Mayor and Board of Commissioners of the Town of West New York that the License Fees set forth in Section 114-19 above shall be in effect for the **2012-2013** license year.
