

**TOWN OF WEST NEW YORK

ORDINANCE NO. 22/11**

**AN ORDINANCE APPROVING AN EXTENSION OF
THE RESIDENTIAL PERMIT PARKING ZONE**

Whereas, the Town of West New York (the “Town”) currently has an Ordinance authorizing the Parking Authority of the Town of West New York (the “Authority”) to establish the Residential Permit Parking Zone (“RPP Zone”) in the Town and the regulations within, subject to approval by the Mayor and Board of Commissioners of the Town; and

Whereas, the Authority desires to extend the existing RPP Zone to include Broadway to Bergenline Avenue from 51st Street to 67th Street in the Town, from the hours of nine o’clock in the evening (9:00 p.m.) to seven o’clock in the morning (7:00 a.m.) the following morning; and

Whereas, pursuant to the Town’s Ordinance, Article XII, Section 227-25, the Board of commissioners of the Authority passed Resolution 11-034 on September 20, 2011, authorizing the extension of the RPP Zone to include Broadway to Bergenline Avenue from 51st Street to 67th Street in the Town, from the hours of nine o’clock in the evening (9:00 p.m.) to seven o’clock in the morning (7:00 a.m.) the following morning; and

Whereas, the Town has now determined that it is in the public interest to adopt the recommendation and Resolution 11-034 of the Authority, and pass an Ordinance authorizing the proposed extension of the RPP Zone in the Town.

Now, Therefore, Be It Ordained That the Board of Commissioners of the Town of West New York does hereby approve Resolution 11-034 of the Parking Authority of West New York, and adopt the extension of the RPP Zone to include Broadway to Bergenline Avenue from 51st Street to 67th Street in the Town, from the hours of nine o’clock in the evening (9:00 p.m.) to seven o’clock in the morning (7:00 a.m.) the following morning.

Be It Further Ordained That in accordance with Article XII, Section 277-35 of the Town Ordinance, the “Schedule of Residential Permit Parking Only Streets” maintained by the Township Municipal Clerk’s office, shall be amended to reflect the aforementioned extension to the RRP Zone.
