ORDINANCE #3/12

**AN ORDINANCE amending Chapter 186 of the Code of the Town
Of West New York**

Be it Ordained by the Mayor and Board of Commissioners of the Town of West New York that Chapter 186 is hereby amended as follows:

Section 1.

Chapter 186-10 H is amended to read as follows:

H. Health Department Fees.

(1) Vital statistics.

(a) Marriages (fees mandated by State of New Jersey): \$28.

(b) Marriage copies (fees mandated by State of New Jersey): \$10.

(c) Birth copies: \$10.

(2) Health Department.

(a) Retail food: \$125.

(b) Restaurants:

[1] Forty to 59: \$175.

[2] Sixty and over: \$225.

(c) Supermarkets:

[1] Two thousand five hundred: \$150.

[2] Four thousand and over: \$200.

(d) Beauty parlor/Hair salon: \$75.

(e) Nail salons: \$75.

(f) Barbers: \$75.

(g) Vendors: \$275.

(h) Agents: \$75.

(i) Figure, exercise and diet salons: \$75.

(j) Exercise clubs: \$275.

(k) Swimming pool: \$250.

(l) Solid waste: \$75.

(m) Poultry: \$200.

(n) Pet: \$75.

(o) Laundry:

[1] Per machine: \$30.

[2] Per dryer: \$30.

(p) Milk: \$50.

(q) Milk depot: \$150.

(r) Dog license:

[1] Neutered/Spayed): \$8.

[2] Unneutered/Unspayed: \$11.

(s) Death transcripts: \$10.

(t) Burial permits: \$10.

Section 2. Any or all other ordinances or parts thereof in conflict or inconsistent with any of the terms hereof are hereby repealed to such extent as they are so in conflict or inconsistent.

Section 3. In case any article, section or provision of this ordinance shall be held invalid in any court of competent jurisdiction, the same shall not affect any other article, section or provision of this ordinance except insofar as the article or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

Section 4. This ordinance shall become effective immediately upon final passage and publication as required by law.

The foregoing Ordinance was adopted for first reading by the Mayor and Board of Commissioners of the Town of West New York, New Jersey, on **January 18, 2012** and ordered published, and will be further considered before final passage at a public hearing on **February 15, 2012 at 7:00 P.M.** at the Commission Chambers, Municipal Building, West New York, NJ.
