**Re: Establishing the Rate of Interest to be charged on Delinquent Taxes**

Whereas, pursuant to the State of New Jersey, a municipality may charge a rate of interest not exceeding 8% per annum on the first \$1,500 of delinquency, nor more than 18% on any delinquencies in excess of \$1,500; and

Whereas, a delinquency is defined as “the total of all unpaid taxes and municipal charges (including interest) due on a property covering any number of quarters or years; and

Whereas, interest will be calculated from the first day of each Tax Quarter, that being, February 1<sup>st</sup>, May 1<sup>st</sup>, August 1<sup>st</sup>, and November 1<sup>st</sup>, after the grace period has expired; and

Whereas, it is desirous for the Mayor and Board of Commissioners to reduce the unnecessary burden of the State’s limit of 8% on the first \$1,500 and 18% on any delinquencies in excess of \$1,500; and

Whereas, it is desirous of the Town of West New York Board of Commissioners to charge 3% on all delinquent taxes from the date due until the date of actual payment commencing on August 1, 2011;

Now, therefore, be it resolved by the Mayor and Board of Commissioners of the Town of West New York that the interest rate being applied shall be 3% on all delinquent balances from all past quarters and currently through February 1, 2012;

Be it further resolved that existing tax title liens held by third party purchasers shall remain at the interest rate of the successful bidder at the time of the tax sale. Any future tax payments on the existing lien shall be limited to the amended interest rate of 3% as established by this resolution.

**Ordinance #17/11**

**Re: An Ordinance approving financial agreement between the Town of  
West New York & Riverwalk G Urban Renewal, LLC for Construction of  
316 residential apartments located on Lot 7.10 Block 168.01**

**Note:** Town Attorney Julio Morejon read the title of the foregoing Ordinance aloud.

The foregoing Ordinance having been presented according to law, Mayor Roque called for a hearing thereon.

**The following persons wished to be heard:**

**1. Cosmo Cirillo, 116 – 65<sup>th</sup> Street, WNY:**

Mr. Cirillo inquired as to the length of time of tax abatement to which Mayor Roque responded “30 years. The Mayor further commented that former Mayor Sires had a vision of what the waterfront looks like today and West New York needs development. The Mayor further commented that the past 4 years, the prior Administration did not allow development. Mr. Cirillo inquired as to why the time period of the abatement is so long?

Mayor commented that if this is what it takes, then we have to allow it and have them build. Commissioner Rodriguez asked Mr. Cirillo “Were you born in the 80’s? Do you have any memory of what the waterfront looked like? In the 12 years of Albio Sires’ Administration, the taxes where not raised. Why didn’t the Vega Administration not do the same? Vega should have negotiated an abatement to help bring revenue to this town but instead he had a 51% tax increase. Let me tell you something he did it the lazy way. This project will bring jobs to town residents. This will not hurt but it will benefit the town.” Mr. Cirillo inquired “Is 30% going to the school system?” Mayor asked Mr. Cirillo “How many children from the waterfront attend our public schools at the present time?” Mr. Cirillo responded “8”. Mayor responded “8 students out of 4000 residents”. Commissioner Rodriguez commented “regardless of the percent that we agree on, we are an Abbott District and 100% comes from Abbott.” Mr. Cirillo commented “if we don’t have the funding necessary, there will not be enough money for our children”.

Commissioner Rodriguez replied “we will never leave our kids with no money.” Mayor Roque asked Mr. Brian O’Reilly to speak on behalf of the town to explain the abatement system. Mr. O’Reilly stated that he was the consultant for the town for 18 months, he was also Business Administrator for 20 years for Jersey City and that he also owns a small company which reviews Tax Abatements. He advised Mr. Cirillo that since 2003 there is no requirement of any tax abatement money to go toward schools. Mr. Cirillo inquired “no money”? Mr. O’Reilly responded “no money”. Mayor Roque responded to Mr. Cirillo, “I understand your concern. There is no shortage. There will be \$13 million dollars coming from the Governor which you won’t be there to see. No kid is suffering right now; the ones suffering are the taxpayers with the 51% tax increase. We will lower our taxes.” Commissioner Wiley commented that a decision has been made and this will only benefit the Town and that they have their own garbage pickup, snow removal, etc. He further commented that this will not hurt West New York in any way but it will make the Town grow and will give builders incentive to come to West New York to build.

This is what will make this Town grow. Mr. Cirillo commented that they had not answered his question. Mayor Roque responded, “Please show some respect. We have given you all straight answers, more than that we cannot do.” Commissioner Rodriguez reiterated that the Commissioners have given him all straight answers. Mr. Cirillo said as a final statement, “It is obvious that this is a very important issue”. Town Attorney Morejon advised Mr. Cirillo that he had five more minutes. Mayor Roque commented that the prior Mayor only permitted a total of 5 minutes. Mr. Cirillo inquired, “Aren’t you voting on this tonight? I encourage that you don’t vote on this today”.

**2. Beatrice Pelaz-Martinez, 211 – 53<sup>rd</sup> Street, WNY:**

Ms. Pelaz-Martinez commented that as a property owner and a West New York resident all her life she would like to raise her children here and have them enjoy this town as much as she did, but if it continued the way it is she won't be able to do so. She stated "I love this town" and that she received a letter from WNY First and that it concerns her. She further commented that taxes went up 51% last year due to the past administration. She further commented that West New York is divided into two sections, the upper portion and the waterfront portion and that her friends ask why she still lives here. Mayor responded, "First of all I would like to say that the people who wrote that letter are a bunch of cowards". Mayor Roque read aloud the letter sent from WNY First. He commented that Riverwalk will bring in a lot of revenue to this Town. Assistant Town Attorney DeMarco advised that this project will cost in excess of \$118 million dollars and that a bank will only loan that kind of money with a tax abatement with a safeguard in an agreement. Mr. O'Reilly explained the breakdown of the number of one & two bedroom units that will be in the 316 total units. Ms. Pelaz-Martinez commented that West New York is not like Jersey City, which is much bigger, and that West New York should be united, not divided.

**3. Henrietta Dwyer, 16 – 62<sup>nd</sup> Street, WNY:**

Ms. Dwyer indicated that she is not very familiar with tax abatements and inquired as to whether this would look like Jersey City's waterfront, which consists of glass buildings and not much waterfront. Mr. O'Reilly explained that he had received his experience from working in Jersey City, not that this project would be like Jersey City. Ms. Dwyer expressed her opinion that the Town should hold on to the piece of open land. Mayor Roque explained that the developers own the land upon which they wish to build and that it is the developer's decision to build what is permissible. Ms. Dwyer commented that \$1,600 is a lot of money for a 1-bedroom unit. Discussion ensued between Ms. Dwyer and Comm. Rodriguez regarding rising taxes. Commissioner Rodriguez commented that from 1995-2006 taxes did not increase and that the waterfront development is the reason taxes did not increase in those years. Ms. Dwyer said she wanted to wish the Mayor and all the Commissioners lots of luck and to continue being honest, and that it takes a lot of courage to do what they do. Commissioner Rodriguez said that between 1995-2006 the taxes were stable but that in the last 4 years had skyrocketed, and that the prior Administration was spending money as if it were theirs. Commissioner Rodriguez asked Ms. Dwyer if she lived around the corner from her and Ms. Dwyer responded "yes, but you didn't vote for me."

**4. Maria Dones, 200 – 49<sup>th</sup> Street, Union City:**

Ms. Dones spoke in Spanish. Mayor Roque translated and advised that she wanted to express her appreciation to Commissioner Wiley for his great work during the Hurricane Irene clean up.

**5. Humberto Ortega, 6040 Blvd. East, WNY:**

Mr. Ortega expressed that he had some questions regarding this tax abatement. He stated that he lived in town and owned his apartment since 1973. He wanted to know why the waterfront property owners pay less taxes than he pays, and commented that the average apartment on the waterfront pays 37% less in taxes than the average apartment and that they pay 15% less than him. He asked how many units were being proposed in this development. Mr. O'Reilly advised that there would be 316 mixed units. Mr. Ortega asked how the percentage is justifiable. He stated that townhouses are much bigger than his condo. Mr. O'Reilly indicated that the people in Jacob's Ferry pay three times as much as the people on top of the cliff. Assistant Town Attorney DeMarco responded that \$1.3 million dollars revenue will be realized. Mr. O'Reilly advised that condo and co-op owners are shareholders and can't appeal their taxes.

**6. Ken Blane, 6040 Blvd. East, WNY:**

Mr. Blane suggested that the abatement be for less than 30 years. Asst. Town Attorney DeMarco commented that this project will bring additional 40% more revenue within the 30 year period. Mr. Blane suggested that further research be done prior to approving this Ordinance. He explained that as a member of the WNY Zoning Board, they make every effort in the best interest of the Town and that at the end of the day, the members know they did the best that they could. Mr. Blane also welcomed Joe Rodriguez to the Zoning Board.

**7. Jennifer Shaty, 6040 Blvd. East, WNY:**

Ms. Shaty commented that this Tax Abatement is encouraging more development on the waterfront, and inquired "Do we need more residents in West New York?" Mayor Roque commented that he welcomes all buyers and builders to West New York and that this is a huge piece of property upon which the owner has decided to build. He further commented that it is the owner's decision to do what they wish with this property, and that the banks will not lend money unless there is tax abatement involved. He explained that this is an opportunity to bring in revenue so that taxes do not have to be increased. Commissioner Frias explained that town residents will have top priority in obtaining jobs which will be created as a result of this project. Ms. Shaty inquired as to why this property could not be sold to a builder who doesn't need a tax abatement. Mayor Roque explained that with economic times, it is not easy to have all the money required to develop without tax abatements and that this new development will substantially increase the Town's revenue with the anticipation of lowering taxes over the next four years.

**1. Gary Morrison, 606 – 56<sup>th</sup> Street, WNY:**

Mr. Morrison commented that he wanted to say “Hello” to Commissioner Rodriguez and commented that she is a wonderful person. He commented that he remembers going to Mr. Turner’s office and that he always took care of him. He advised that he was present due to the two crossing guards who were terminated. Town Attorney Morejon advised that this is a personnel issue and that inasmuch as the persons involved were not present, the Commissioners would not be able to discuss this matter. Mr. Morrison expressed his gratitude to Commissioner Wiley.

**2. Humberto Ortega, 6040 Blvd. East, WNY:**

Mr. Ortega inquired as to what changes are being made in this Bond Ordinance. Commissioner Wiley explained that in the prior Bond Ordinance approved in February money was allocated for two (2) skid steers, but in the best interest of the town a Street sweeper would be of more use. He further explained that there is a part of the town that is currently not swept, and that with the new sweeper services could be provided to that section of town. In addition revenue would be generated. He further explained that there are two (2) broken sweepers which are operating with minimal equipment.

**3. Gary Polack, 229 – 49<sup>th</sup> Street, Union City:**

Mr. Polack expressed his concerns regarding the Jitney Buses operating on Bergenline Avenue and commented that Mayors Stack and Sacco are not in favor of them. He suggested that demand be made of New Jersey Transit for additional buses in our area.

**4. Bill Parkinson, 419A – 57<sup>th</sup> Street, WNY:**

Mr. Parkinson advised that he has been a West New York resident for 55 years and a veteran of the Navy. He referred to a recent incident when a Board of Education employee was terminated allegedly due to politics and staged a hunger strike for the purpose of being re-hired. He commented that the same thing happened to him. He commented to Comm. Wiley that he had spoken to his dad and that he understands how difficult it is to run the DPW Dept with only 30 men. Mr. Parkinson further commented that he feels he was a victim of politics. Mr. Parkinson asked the Mayor “Why did you fire me. Give me a reason why I was fired.” Mayor Roque responded that he has great qualities but that these things happen.

**5. Ron Scheurle, 6119 Tyler Place, WNY:**

Mr. Scheurle reminded the Mayor that at a previous Commission meeting the Mayor had requested him to supply him with a list of the names of the new employees who Mr. Scheurle alleged were not town residents. Mr. Scheurle commented that they should not have been hired due to the Town’s residency Ordinance. Commissioner Wiley asked Mr. Scheurle how many times he questioned the past Administration about the out of town employees that were hired. Assistant Town Attorney DeMarco advised that they cannot discuss personnel matters and that discussing such issues would be a violation of their rights and that the Town would be at risk grievances being filed against it. Town Attorney Morejon commented that as Chief Steward, Mr. Scheurle knows about the restrictions of discussing personnel issues.

**6. Ricardo Montero, 6121 Jefferson Street, WNY:**

Mr. Montero spoke Spanish so Comm. Rodriguez translated for him. He advised that he is presently the President of the Cuban Prisoners’ of War, and that he wanted to thank the Mayor for supporting Mayor Stack’s decision not to allow the President of Ecuador to attend the Cultural Affairs celebration at the Jose Marti School in Union City due to his ties to communist leaders Chavez, Fidel Castro and his brother Raul Castro. Mr. Montero thanked the administration and wished them lots of luck.
