ORDINANCE #16/19

**AN ORDINANCE AMENDING CHAPTER 186 OF THE CODE OF THE TOWN OF WEST
NEW YORK AND AMENDING DESIGNATED CHAPTERS OF THE CODE OF THE TOWN
OF WEST NEW YORK FOR INCORPORATION IN CHAPTER 186 OF THE CODE OF THE
TOWN OF WEST NEW YORK**

WHEREAS, pursuant to N.J.S.A. 40:48-2, a municipality may make, amend, repeal and enforce ordinances not contrary to the laws of this State or of the United States, as it may deem necessary and proper for order and protection of persons and property, and for the preservation of the public health, safety and welfare of the municipality and its inhabitants; and,

WHEREAS, Chapter 186 outlines fees that the Town of West New York charges for various municipal services and other items; and,

WHEREAS, the intent of this Chapter is to outline and synthesize all of the municipal fees that the Town of West New York may charge; and,

WHEREAS, the Mayor and the Board of Commissioners of the Town of West New York, in order to ensure sufficient efficiency, effectiveness, and transparency in the administration of the municipal operations of the Town, wish to include all fees from other chapters and incorporate same into Chapter 186.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Commissioners of the Town of West New York, that Chapter 186, as well as all of the other chapters of the Code of the Town of West New York with fees included, shall be amended as follows:

Section One

Chapter 186-10D(2)(e)(f) and (m) shall be deleted and replaced as follows:

- (e) Bartender/waiter or any employee (each establishment): \$75.
- (f) Go-Go dancers (each establishment): \$100.
- (m) Pool tables: \$250.

Section Two

Chapter 186-10D(3)(a) shall be deleted and replaced as follows:

- (a) Driveway painting: \$30

Section Three

Chapter 186-10H(2)(d) and (e) shall be deleted and replaced as follows:

- (d) Beauty parlor/hair salon/barbershop: \$75.
 - 1. Extended Hour Application Fee: \$50.00

(e) Nail salons: \$75.

1. Extended Hour Application Fee: \$50.00

Section Four

Chapter 186-13A shall be deleted and replaced as follows:

A. The Mayor may collect fees for performing marriage and civil union ceremonies in the amount of \$75 per ceremony.

Section Five

The below listed Chapter titles shall remain and the fee language for each shall be deleted and moved to Chapter 186, where each chapter's fee(s) section will be listed separately, beginning at 186-10N. Section Six

Severability. The provisions of this Ordinance are declared to be severable and if any section, subsection, sentence, clause or phrase thereof for any reason be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, subsections, sentences, clauses and phrases of this Ordinance, but shall remaining in effect; it being the legislative intent that this Ordinance shall stand notwithstanding the invalidity of any part.

Section Seven

Repealer. All ordinances or portions thereof in conflict or inconsistent with this Ordinance are hereby repealed, but only however, or the extent of such conflict or inconsistency, it being the legislative intent that all ordinances or portions of ordinances now existing now existing or in effect shall remain in effect unless they are in conflict or inconsistent with any provision of this Ordinance.

Section Eight

When Effective. This ordinance shall take effect upon passage and publications as required by law.

SUMMARY OF ORDINANCE

This Ordinance amends Chapter 186 titled “Fees” to include fees from other chapters that had not been referenced herein to make it easier for residents to find. The Chapter also amends the fees to be paid for certain services.
