ORDINANCE #5/20

**AN ORDINANCE AMENDING CHAPTER 361 "SWIMMING POOL",
SECTIONS 9 "FEES AND REGULATIONS ESTABLISHED"
OF THE TOWN OF WEST NEW YORK**

WHEREAS, the Mayor and Board of Commissioners have determined that it is in the best interests of the Town of West New York ("the Town") that certain fees charged for the Swimming Pool be updated and amended.

NOW THEREFORE, BE IT ORDAINED by the Mayor and Board of Commissioners of the Town of West New York, County of Hudson State of New Jersey as follows:

SECTION ONE

Chapter 361, Section 9(A) "Schedule of Membership Fees" of the Code shall be amended to read as follows:

SECTION TWO

Severability. The provisions of this Ordinance are declared to be severable and if any section, subsection, sentence, clause or phrase thereof for any reason be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, subsections, sentences, clauses and phrases of this Ordinance, which shall remain in effect; it being the legislative intent that this Ordinance shall stand notwithstanding the invalidity of any portion thereof.

SECTION THREE

Repealer. All Ordinances or portions thereof in conflict or inconsistent with this Ordinance are hereby repealed, but only however, to the extent of such conflict or inconsistency, it being the legislative intent that all Ordinances or portions of ordinances now existing or in effect shall remain in effect unless they are in conflict or inconsistent with any provision of this Ordinance.

SECTION FOUR

Codification - This ordinance shall be part of the Code as though codified and fully set forth therein. The Town Clerk shall have this ordinance and incorporated in the official copies of the Code. The Town Clerk and the Town Attorney be and are hereby authorized and directed to change any heading, chapter numbers, article numbers and section numbers in the event that the codification of this ordinance reveals that there is a conflict between those headings and numbers and existing provisions of the Code of the Town of West New York and to also codify any fee set forth in this Ordinance in such section of the Code, other than Chapter 361, Sections 9 of the Code, where such fee may currently be codified in the existing provisions of the Code, as may be deemed appropriate.

SECTION FIVE

This Ordinance shall take effect upon passage and publication as required by law.

SUMMARY OF ORDINANCE

This Ordinance amends the fees applicable to non-residents of the town for use of the Town's swimming facilities.
