ORDINANCE #6/20

**AN ORDINANCE AMENDING CHAPTER 93 OF THE CODE OF THE TOWN OF WEST NEW YORK
ENTITLED “SALARIES AND COMPENSATION”**

WHEREAS, the Town of West New York (“Town”) has, in accordance with N.J.S.A. 40A:9-165, set the salaries of its officers and employees by ordinance (“Salary Ordinance”); and,

WHEREAS, the Town’s Board of Commissioners seeks to amend Chapter 93 to reflect a change in the employment titles of Assistant Municipal Administrator to Deputy Municipal Administrator, Assistant Assessor to Deputy Tax Assessor, and adds the following employment titles to the salary guide: Code Enforcement Officer, Communications Specialist/Assistant, Management Information Systems Coordinator, Parking Attendant, Parking Enforcement Office/Meter Collector (Part Time and Full Time), Deputy Police Chief, and Program & Logistics Coordinator to its Salary Ordinance; and,

WHEREAS, the Town’s Board of Commissioners seeks to amend Chapter 93 to provide the salary range for certain municipal employees as follows:

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Town of West New York, that the foregoing ordinance is hereby amended to reflect a change in the employment titles of Assistant Municipal Administrator to Deputy Municipal Administrator, Assistant Assessor to Deputy Tax Assessor, and adds the following employment titles to the salary guide: Code Enforcement Officer, Communications Specialist/Assistant, Management Information Systems Coordinator, Parking Attendant, Parking Enforcement Office/Meter Collector (Part Time and Full Time), Deputy Police Chief, and Program & Logistics Coordinator to its Salary Ordinance.

BE IT FURTHER RESOLVED, by the Board of Commissioners of the Town of West New York that the foregoing ordinance is hereby amended to provide the salary range for the following municipal employees:

BE IT FURTHER RESOLVED, by the Board of Commissioners of the Town of West New York that the salary ranges of the remaining employment titles shall remain unchanged.

SECTION ONE

Severability. The Provisions of this Ordinance are separable and if any provision, clause, sentence, subsection, word or part thereof is held illegal, invalid, or unconstitutional, or inapplicable to any person or circumstance, such illegality, invalidity or unconstitutionality, or inapplicability shall not affect or impair any of the remaining provisions clauses, sentences, subsections, words, or parts of the regulation or their application to other persons or circumstances. It is hereby declared to be the legislative intent that this Ordinance would have been adopted if such illegal, invalid, or unconstitutional provision, clause words, or parts, of the regulation of their application to other persons or circumstances. It is hereby declared to be the legislative intent that this Ordinance would have been adopted if such illegal, invalid, or unconstitutional provision, clause, sentence, subsection, work or part had not been included therein, and if such persons or circumstances, to which the ordinance or part thereof is held inapplicable, had been specifically exempted there from.

SECTION TWO

Repealer. All other ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed, to the extent of such inconsistency.

SECTION THREE

This Ordinance shall take effect upon passage and publication as required by law.

SUMMARY OF ORDINANCE

This Ordinance:

1. Changes the employment titles and salary range of Assistant Municipal Administrator to Deputy Municipal Administrator and Assistant Assessor to Deputy Tax Assessor; and,
2. Adds the employment titles and salary ranges of Code Enforcement Officer, Communications Specialist/Assistant, Management Information Systems Coordinator, Parking Attendant, Parking Enforcement Office/Meter Collector (Part Time and Full Time), Deputy Police Chief, and Program & Logistics Coordinator.

The salary ranges of the remaining employment titles shall remain unchanged.
