**ORDINANCE #22/15**

**AN ORDINANCE AMENDING DESIGNATION OF DROP OFF ZONE  
AS PROVIDED BY THE AMERICANS WITH DISABILITIES ACT**

**WHEREAS**, the Town of West New York has established a drop off zone in accordance with the Americans with Disabilities Act on Tyler Place and 60<sup>th</sup> Street by the Town Hall by Ordinance No. 26/00; and

**WHEREAS**, the Town of West New York has determined that the location of this “drop off zone” is dangerous when the North Hudson Regional Fire and Rescue responds to calls and therefor the location of this drop off zone should be moved.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Board of Commissioners that:

**SECTION ONE**

The handicap drop off zone located on Tyler Place 104 feet along the Northwest corner of Tyler place and 60<sup>th</sup> Street running 33 feet there from shall be rescinded and the following substituted therefor:

Begin at a point, along the West Side of Tyler Place 150 feet North from the Northwest corner of 60<sup>th</sup> Street and Tyler Place then 22 feet therefrom.

**SECTION TWO**

**Severability.** The provisions of this Ordinance are declared to be severable and if any section, subsection, sentence, clause or phrase thereof for any reason be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, subsections, sentences, clauses and phrases of this Ordinance, but shall remaining in effect; it being the legislative intent that this Ordinance shall stand notwithstanding the invalidity of any part.

**SECTION THREE**

**Repealer.** All Ordinances or parts thereof in conflict or inconsistent with this Ordinance are hereby repealed, but only however, to the extent of such conflict or inconsistency, it being the legislative intent that all Ordinances or part of ordinances now existing or in effect unless the same being conflict or inconsistent with any provision of this Ordinance shall remain in effect.

## **SECTION FOUR**

This Ordinance shall take effect upon passage and publication as required by law.

### **SUMMARY OF ORDINANCE**

This Ordinance changes the location of the handicap drop off zone by the Town Hall.
