ORDINANCE #24/15

**AN ORDINANCE AMENDING CHAPTER 181 SECTION 4(A) OF THE TOWN OF
WEST NEW YORK MUNICIPAL CODE REGARDING THE FEE FOR PERMITS FOR
DUMPSTER/CONSTRUCTION CONTAINERS**

WHEREAS, Chapter 181 Section 4(A) of the Town of West New York Municipal Code governs the fees for permits for dumpster/construction containers; and,

WHEREAS, Chapter 181 Section 4(A) of the Town of West New York Municipal Code sets the fee for such applications as \$75 per week for each dumpster/construction container; and,

WHEREAS, the Town is desirous of changing the amount of the fees set forth in Chapter 181 Section 4(A) of the Town of West New York Municipal Code to \$100.00.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Commissioners of the Town of West New York that:

SECTION ONE

Chapter 181 Section 4(A) of the Town of West New York Municipal Code shall be deleted in its entirety and the following substituted therefore:

The fee payable for permits issued under this chapter shall be \$100 per week for each dumpster/construction container.

SECTION TWO

Severability. The provisions of this Ordinance are declared to be severable and if any section, subsection, sentence, clause or phrase thereof for any reason be held to be invalid or unconstitutional, such decision shall not effect the validity of the remaining sections, subsections, sentences, clauses and phrases of this Ordinance, but shall remaining in effect; it being the legislative intent that this Ordinance shall stand notwithstanding the invalidity of any part.

SECTION THREE

Repealer. All Ordinances or parts thereof in conflict or inconsistent with this Ordinance are hereby repealed, but only however, to the extent of such conflict or inconsistency, it being the legislative intent that all Ordinances or part of ordinances now existing or in effect unless the same being conflict or inconsistent with any provision of this Ordinance shall remain in effect.

SECTION FOUR

This Ordinance shall take effect upon passage and publication as required by law.

SUMMARY OF ORDINANCE

This Ordinance changes fees for applications filed for permits for dumpster/construction containers from \$75 to \$100 per week.
