ORDINANCE #28/17

**AN ORDINANCE OF THE CODE OF THE TOWN OF WEST NEW YORK ENTITLED
“SANITATION DIVISION”**

WHEREAS, the Town of West New York (“Town”) has determined to bring its solid waste collection and disposal services in-house; and

WHEREAS, in light of the Town’s intent to bring its solid waste collection and disposal services in-house, the Town’s Board of Commissioners deem it necessary for the general order of the municipality that the Town have a Sanitation Division; and

WHEREAS, the Town’s Board of Commissioners deem that, in order to be in compliance with the affairs of the Town, a new ordinance creating the Sanitation Division is beneficial to the public welfare and general order of the Town; and

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Commissioners of the Town of West New York that the Town Code shall be amended to add the following:

SECTION ONE

1. Creation of the Sanitation Division.

There shall hereby be created a Sanitation Division that will be organized under the Department of Public Works.

2. Designation of a Sanitation Director

There shall also be created the position of Sanitation Director. The Sanitation Director shall be responsible for the daily operations of the Sanitation Division and shall report to the Superintendent of the Department of Public Works.

3. Functions of the Sanitation Division

The Sanitation Division will be primarily charged with the day-to-day responsibility of solid waste collection and disposal in the Town of West New York, with the exception of commercial premises and other specific properties. The Sanitation Division may also take on other functions as determined by the Town.

SECTION TWO

Severability. The provisions of this Ordinance are declared to be severable and if any section, subsection, sentence, clause or phrase thereof for any reason be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, subsections, sentences, clauses and phrases of this Ordinance, but shall remaining in effect; it being the legislative intent that this Ordinance shall stand notwithstanding the invalidity of any part.

SECTION THREE

Repealer. All ordinances or portions thereof in conflict or inconsistent with this Ordinance are hereby repealed, but only however, or the extent of such conflict or inconsistency, it being legislative intent that all ordinances or portions of ordinances now existing or in effect shall remain in effect unless the they are in conflict or inconsistent with any provision of this Ordinance.

SECTION FOUR

When Effective. This ordinance shall take effect upon passage and publication as required by law.

SUMMARY OF ORDINANCE

This Ordinance creates a Sanitation Division that will be organized under the Department of Public Works and also creates the position of Sanitation Director. The Sanitation Director shall be responsible for the daily operations of the Sanitation Division and shall report to the Superintendent of the Department of Public Works. The Sanitation Division will be primarily charged with the day-to-day responsibility of solid waste collection and disposal, with the exception of commercial premises and other specific properties.
