ORDINANCE #5/15

**AN ORDINANCE AMENDING CHAPTER 161 OF THE CODE OF THE
TOWN OF WEST NEW YORK ENTITLED “CONSTRUCTION CODE, UNIFORM”**

WHEREAS, the Town of West New York establishes fees for permits etc. for the various building subcodes; and

WHEREAS, it has been determined that several of these fees should be revised and updated; and,

NOW THEREFORE, BE IT ORDAINED by the Mayor and Board of Commissioners of the Town of West New York that Section 161-2 Fees shall be amended as to the following fees:

SECTION ONE

Section 161-2 FEES

(2) Plumbing Subcode Fees

A. Up to ¾ inch	\$100.00	No change
B. 1 inch	-----	\$150.00
C. Over 1 inch	-----	\$175.00

(3) Electrical Subcode Fees

Service Panels, Service Entrance, Subpanels		
A. Up to 200 amps each	\$125.00	No change
B. 301-1,000 amps	-----	\$450.00
C. 1,001 amps and over	-----	\$675.00

SECTION TWO

Violations and penalties

Any person who shall violate or fail to comply with the provisions of this chapter shall be subject, upon conviction, to the penalties provided in Section 1-16 of the Code of the Town of West New York.

SECTION THREE

Severability. The provisions of this Ordinance are declared to be severable and if any section, subsection, sentence, clause or phrase thereof for any reason be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, subsections, sentences, clauses and phrases of this Ordinance, but shall remaining in effect; it being the legislative intent that this Ordinance shall stand notwithstanding the invalidity of any part.

SECTION FOUR

Repealer. All Ordinances or parts thereof in conflict or inconsistent with this Ordinance are hereby repealed, but only however, to the extent of such conflict or inconsistency, it being the legislative intent that all Ordinances or part of ordinances now existing or in effect unless the same being conflict or inconsistent with any provision of this Ordinance shall remain in effect.

SECTION FIVE

This Ordinance shall take effect upon passage and publication as required by law.

SUMMARY OF ORDINANCE

This Ordinance establishes updated subcode fees for various permits.
