Rules and Guidelines

Hours: 8:00 AM to 8:00 PM

Maintenance: Plot-weeding, litter pick-up, removing rotten and diseased fruits and vegetables. Dispose of them at the compost bin. If a gardener cannot maintain their plot, they must notify the Sustainability Coordinator/ Mayor's Office.

Garden Beds: Garden Beds cannot be painted or drawn on.

Watering System: The hose must be turned off after each use.

Fertilizer and Pesticides: Toxic fertilizers, soil, insecticides, and weed repellent will not be acceptable. A list will be given to each gardener.

Plants: Invasive and poisonous plants will not be accepted. A list will be given to each gardener.

Pets: Pets will not be allowed in the garden.

Behavior: Gardeners will respect each other's plots and space. The Town will not be held accountable for missing or damaged items. Gardeners damaging raised beds and property will be held accountable. Only crops from your plot will be harvested unless given

permission from other gardeners.

Children/ Guests: Children in the garden must be supervised at all times. Any visitors must conduct themselves accordingly while visiting the garden. The Town will not be held responsible for any injuries sustained by any child, visitor, or guest.

Violations: If a plot is not maintained a three-week notice will be given to the gardener. After the three weeks, the plot will be revoked and be reassigned.

In the event the gardener violates any of these rules and guidelines, a written warning by the Sustainability Coordinator will be issued. A gardener, with reason, will be able to correct their actions within one (1) calendar week of the date of the written warning. If there's no response, the gardener will be suspended and forfeit their gardening privileges. Depending on the severity of the violation, the gardener will be able to be re-apply and placed on a waiting list. No refund will be given to suspended and revoked gardeners.
