**ORDINANCE #14/14**

**AN ORDINANCE AMENDING CHAPTER 254 SECTION 9 OF THE  
TOWN OF WEST NEW YORK MUNICIPAL CODE REGARDING THE  
FEE FOR APPLICATIONS FILED FOR A MOBILE OR STREET  
VENDOR LICENSE**

**WHEREAS**, Chapter 254 Section 9 of the Town of West New York Municipal Code governs the fees for applications filed for a mobile or street vendor license; and,

**WHEREAS**, Chapter 254 Section 9 of the Town of West New York Municipal Code sets the fee for such applications as \$250 for each truck or stand in which the licensee seeks to be permitted in the Town of West New York and an additional \$250 for each additional vehicle or stand added by the licensee; and,

**WHEREAS**, the Town is desirous of changing the amount of the fees set forth in Chapter 254 Section 9 of the Town of West New York Municipal Code to \$275.00.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Board of Commissioners of the Town of West New York that:

**SECTION ONE**

Chapter 254 Section 9 of the Town of West New York Municipal Code shall be deleted in its entirety and the following substituted therefore:

For each truck or stand in which the licensee seeks to be permitted in the town, a fee of \$275 shall be filed with the Health Department at the time of the filing of the application. Each additional vehicle or stand added by the licensee shall increase the licensee's fee by \$275.

**SECTION TWO**

**Severability.** The provisions of this Ordinance are declared to be severable and if any section, subsection, sentence, clause or phrase thereof for any reason be held to be invalid or unconstitutional, such decision shall not effect the validity of the remaining sections, subsections, sentences, clauses and phrases of this Ordinance, but shall remain in effect; it

being the legislative intent that this Ordinance shall stand notwithstanding the invalidity of any part.

### **SECTION THREE**

**Repealer.** All Ordinances or parts thereof in conflict or inconsistent with this Ordinance are hereby repealed, but only however, to the extent of such conflict or inconsistency, it being the legislative intent that all Ordinances or part of ordinances now existing or in effect unless the same being conflict or inconsistent with any provision of this Ordinance shall remain in effect.

### **SECTION FOUR**

This Ordinance shall take effect upon passage and publication as required by law.

### **SUMMARY OF ORDINANCE**

This Ordinance changes fees for applications filed for a mobile or street vendor license from \$250 to \$275.
