ORDINANCE #3/14

AN ORDINANCE AMENDING CHAPTERS 284 OF THE CODE OF THE TOWN OF WEST NEW YORK REGARDING PEDDLING AND SOLICITING AND CREATING A FARMER'S MARKET

WHEREAS, Chapter 284 of the Town of West New York Municipal governs the registration and licenses of peddling, soliciting and other related activities within the Town of West New York and

WHEREAS, the Town is desirous of establishing procedures for the creation of a Farmer's market to increase the availability of fresh produce and enhance the quality of life of its residents:

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Commissioners of the Town of West New York that Chapters 284 of the Code of the Town be amended as follows:

Chapter 284 Peddling and Soliciting

Section 284-22 Farmer's Market:

- A. An outdoor farmer's market is permitted to be held under the direction of the Department of Public Affairs from May 1 to November 1 each calendar year. The location of the Farmer's market shall be set by the Town. The number of vendors to be permitted shall be set by the Commissioner of Public Affairs.
- B. Hours of Operation are from 2pm to 8pm Thursdays. The hours and day of the Framers market are subject to change by the Commissioner of the Department of Public Affairs. No Vendor shall be allowed to occupy the site earlier than one hour prior to the start time for purposes of setup and shall occupy the site no longer than one hour after the designated closing time for clean up. Each vendor is required to return the site in a clean broom swept condition free of litter and debris.
- C. Each Vendor is required to submit an application to the Department of Public Affairs. Each applicant shall provide information regarding the type of products to be sold, the address of

the vendor, the identity of any authorized agents or employees and proof of insurance. Issuance of a permit shall be valid for the calendar year in which the application is approved.

D. All vendors are required to comply with all state, county and local ordinances and

regulations regarding health and fire safety. All products for sale shall comply with State Health

Regulations.

E. Each Vendor will be limited to an assigned space to be determined by the Town. The

Vendor is responsible to maintain the area clean and free of obstruction to the public right of

way.

F. Each Vendor is required to submit an annual \$250 application fee.

Any or all other ordinances or parts thereof in conflict or inconsistent with any of the terms

hereof are hereby repealed to such extent as they are so in conflict or inconsistent.

In case any article, section or provision of this ordinance shall be held invalid in any court of competent jurisdiction, the same shall not affect any other article, section or provision of this ordinance except insofar as the article or provision so declared invalid shall be inseparable from the remainder or

any portion thereof.

This ordinance shall become effective immediately upon final passage and publication as required

by law.
