ORDINANCE #14/19

**AN ORDINANCE DESIGNATING CERTAIN STREETS IN THE
TOWN OF WEST NEW YORK AS ONE WAY**

WHEREAS, pursuant to N.J.S.A. 39:4-197(1)c, a municipality may pass an ordinance designating one way streets without the approval of the Commissioner of the Department of Transportation; and,

WHEREAS, it is within the police powers of the Town of West New York to regulate municipal streets; and,

WHEREAS, there are several two-way streets in the Town of West New York (“Town”) that the Mayor and Board of Commissioners seek to convert into one-way streets.

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Board of Commissioners of the Town of West New York, County of Hudson, State of New Jersey that the Code of the Town of West New York is hereby supplemented as follows:

Section One

Designation of One Way Streets

The following two way streets shall be designated as one way:

| <u>Name of Street</u> | <u>Direction of Travel</u> |
|--|-----------------------------------|
| Polk Street – from 66 th Street to 67 th Street | Northbound |
| Polk Street – from 67 th Street to the Town of Guttenberg Border | Southbound |
| Jackson Street – from 67 th Street to the Town of Guttenberg Border | Northbound |

Section Two

Severability. The provisions of this Ordinance are declared to be severable and if any section, subsection, sentence, clause or phrase thereof for any reason be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, subsections, sentences, clauses and phrases of this Ordinance, but shall remaining in effect; it being the legislative intent that this Ordinance shall stand notwithstanding the invalidity of any part.

Section Three

Repealer. All ordinances or portions thereof in conflict or inconsistent with this Ordinance are hereby repealed, but only however, or the extent of such conflict or inconsistency, it being legislative intent that all ordinances or portions of ordinances now existing or in effect shall remain in effect unless the they are in conflict or inconsistent with any provision of this Ordinance.

Section Four

When Effective. This ordinance shall take effect upon passage and publication as required by law.

SUMMARY OF ORDINANCE

This Ordinance designates certain one-way streets and the direction of same.
