Introduction and Purpose

WNYPA is soliciting Proposals from interested persons and/or firms for the provision of FINANCIAL ADVISORY SERVICES CONSULTANT as more particularly described herein. Bond Counsel performs and provides legal advice with regard to the following activities: the preparation of

Through a public process described herein, persons and/or firms interested in applying to the WNYPA for the provision of such Services must prepare and submit a Proposal in accordance with the procedure and schedule in this RFP. WNYPA will review only Proposals that include all the required information as described herein as it intends to award a contract to persons and/or firms that (a) possess the professional capabilities to provide the proposed Services; (b) will agree to work under the compensation terms and conditions set forth; and (c) have demonstrated the capability and willingness to provide high quality services to the WNYPA.

Procurement Process

This RFP process is being undertaken pursuant to the Fair and Open Process described in and in accordance with the "New Jersey Local Unit Pay to Play" Law, <u>N.J.S.A.</u> 19:44A-20.5 <u>et seq.</u> The selection of the Successful Respondent after the completion of the RFP process to perform the Services is subject to said provisions.

Each Respondent that meets the requirements of the RFP (in the sole judgment of WNYPA) will be designated as a Qualified Respondent, and considered for selection by the Authority.

- 1. The successful firm must have significant experience in representing New Jersey municipalities and/or Authorities as Financial Advisor Consultants and be licensed. All candidates are required to comply with N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27 et seq. as amended. (Affirmative Action).
- **2. Appointment Financial Advisory Services Consultant:** A Financial Advisory Services Consultant shall be appointed by the West New York Parking Authority Commissioners for a term of one (1) year.
- **3. Compensation:** Compensation as agreed upon and approved by the Commissioners shall be the basis of payment for services rendered.
- **4. Duties and Responsibilities:** Financial Advisory Services Consultant shall Perform such duties and provide professional services customarily provided by a financial advisor to a governmental entity the size and scope commensurate to that of the West New York Parking Authority and shall include advice and assistance with respect to debt financings and other financial issues contemplated by the Authority including:
 - (a) assistance in formulating the credit structure, maturity schedule, call provisions and other terms and conditions of debt offerings, as required for any other offering;

Submission of Proposals

Proposals must provide all requested information, and must be in strict conformance with the instructions set forth herein:

Subcontractors named in a bid or other proposal shall provide proof of business registration to the applicant, who in turn, shall provide it to the Contracting Agency prior to the time a contract, purchase order, or other contracting document is awarded or authorized.

During the course of contract performance:

- 1. the contractor shall not enter into a contract with a subcontractor unless the subcontractor first provides the contractor with a valid proof of business registration.
- 2. the contractor shall maintain and submit to the Contracting Agency a list of subcontractors and their addresses that may be updated from time to time.
- 3. the contractor and any subcontractor providing goods or performing services under the contract, and each of their affiliates, shall collect and remit to the Director of the Division of Taxation in the Department of the Treasury, the use tax due pursuant to the Sales and Use Tax Act, (N.J.S.A. 54:32B-1 et seq.) on all sales of tangible personal property delivered into the State. Any questions in this regard can be directed to the Division of Taxation at (609)292-6400. Form NJ-REG can be filed online at <a href="https://www.state.nj.us/treasury/revenue/busregcert.shtml">www.state.nj.us/treasury/revenue/busregcert.shtml</a>.

Before final payment is made under the contract, the contractor shall submit to the Contracting Agency a complete and accurate list of all subcontractors used and their addresses.

Pursuant to N.J.S.A. 54:49-4.1, a business organization that fails to provide a copy of a business registration as required, or that provides false business registration information, shall be liable for a penalty of \$25 for each day of violation, not to exceed \$50,000, for each proof of business registration not properly provided under a contract with a contracting agency.

The undersigned acknowledges these requirements and understands that this proposal shall be rejected as nonresponsive if said Contractor fails to comply.
