NOTICE TO BIDDERS Snow Plowing, Salting and Removal Services Contract The West New York Parking Authority Town of West New York, New Jersey

Pursuant to the Fair and Open Process described under N.J.S.A. 19:44A-1, et seq., notice is hereby given by the West New York Parking Authority (WNYPA) that sealed bids for "Snow Plowing, Salting and Removal Services", as directed by the Board of Commissioners of The West New York Parking Authority, will be received on October 14, 2015, at 10:00 A.M. prevailing time at the offices of the WNYPA on 224-60th Street, West New York, NJ 07093, at which time and place the sealed bids will be publicly opened and read. No bids received after that time will be considered.

The West New York Parking Authority intends to award a contract for these services pursuant to N.J.S.A. 40A:11-5. If awarded a contract, your company/firm shall be required to comply with the requirements of N.J.S.A. 10:5-31 et. seq. and N.J.A.C. 17:27 et seq. (Equal Employment Opportunity/ Affirmative Action Program). Bidders are also required to comply with the requirements of P. L. 2004, c.57 which includes the requirement that contractors provide copies of their Business Registration Certificates issued by the New Jersey Department of the Treasury. Bidders are also required to comply with other provisions of law including, but not limited to, the requirements of: N.J.S.A. 52:25-24.2 (P.L. 1977, c. 33, Disclosure of Ownership) N.J.S.A. 52:32-44 (P.L. 2004, c. 57, Business Registration) N.J.S.A. 34.11-56.25, et seq. (P.L. 1963, c. 150, Prevailing Wage) N.J.S.A. 34.11-56.48 (Public Works Contractor Registration). These provisions are incorporated herein by Reference. Full requirements of the Affirmative Action Program may be obtained with the Bid Documents.

Bid Proposals **MUST BE ACCOMPANIED** by a Bid Bond or Certified/Cashier's Check, made payable to the West New York Parking Authority, in an amount equal to Ten (10%) percent of the bid, not to exceed \$20,000.00. All Bidders must have Public Liability Insurance in amounts of \$3,000,000.00 and Workmen's Compensation Liability. Copies of said policies must be furnished with the Bid. The successful firm must have significant experience providing services to New Jersey municipalities and/or authorities.
