**ORDINANCE #5/24**

**AN ORDINANCE OF THE TOWN OF WEST NEW YORK,  
IN THE COUNTY OF HUDSON, NEW JERSEY, AMENDING  
SECTION 3 OF ORDINANCE NO. 29/22 OF THE TOWN  
FINALLY ADOPTED DECEMBER 14, 2022, INCREASING  
THE APPROPRIATION FOR THE ACQUISITION OF  
ELECTRIC SHUTTLE BUSES AND ELECTRIC GARBAGE  
TRUCKS**

THE BOARD OF COMMISSIONERS OF THE TOWN OF WEST NEW YORK, IN THE COUNTY OF HUDSON, NEW JERSEY, DO ORDAIN AS FOLLOWS:

Section 1. Section 3 of Ordinance No. 29/22 of the Town of West New York, in the County of Hudson, New Jersey, finally adopted December 14, 2022, appropriating a \$1,920,198 grant for the acquisition of two (2) electric buses and two (2) electric garbage trucks, is hereby amended to read as follows:

Section 2. The \$2,086,887.57 grant from the State of New Jersey Department of Environmental Protection identified as Grant Identifier AQ22-091 is hereby appropriated for the purchase of two (2) electric shuttle buses and two (2) electric refuse trucks and the decommissioning of two (2) diesel shuttle buses and two (2) refuse trucks, the purchase of two (2) EV charging stations (DCFC) and installation costs, and including all work and materials necessary therefor and incidental thereto.

Section 3. The capital budget or temporary capital budget, as applicable, of the Town is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. In the event of any such inconsistency and amendment, the resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget or temporary capital budget, as applicable, and capital program as approved by the Director of the Division of Local Government Services is on file with the Town Clerk and is available there for public inspection.

Section 3. This ordinance shall take effect in accordance with applicable law.
