**ORDINANCE #29/24**

**AN ORDINANCE OF THE TOWN OF WEST NEW YORK,  
IN THE COUNTY OF HUDSON, NEW JERSEY,  
APPROPRIATING GRANTS FOR VARIOUS PROJECTS IN  
AND FOR THE TOWN OF WEST NEW YORK**

THE BOARD OF COMMISSIONERS OF THE TOWN OF WEST NEW YORK, IN THE COUNTY OF HUDSON, NEW JERSEY, DO ORDAIN AS FOLLOWS:

Section 1. The \$453,107 Community Development Block Grant for Washington Park Improvements referenced in Resolution No. 427-7-2023 adopted by the Board of Commissioners of Hudson County on July 13, 2023, is hereby appropriated for improvements to Washington Park and including all work and materials necessary therefor and incidental thereto.

Section 2. The \$111,500 Energy Efficiency and Conservation Block Grant from the Department of Energy is hereby appropriated for various energy efficiency upgrades and including all work and materials necessary therefor and incidental thereto.

Section 3. The \$72,000 Local Recreation Improvement Grant from the New Jersey Department of Community Affairs as set forth in the letter from the Commissioner of the Department of Community Affairs dated June 23, 2024, is hereby appropriated for improvements to Filmore Park and including all work and materials necessary therefor and incidental thereto.

Section 4. The \$330,000 Open Space, Recreation and Historic Prevention Trust Fund Grant for Fillmore Park Improvement Project (Playground) approved by the Board of Commissioners of Hudson County at a public hearing held on August 8, 2024, is hereby appropriated for improvements to Filmore Park and including all work and materials necessary therefor and incidental thereto.

Section 5. The \$300,000 Open Space, Recreation and Historic Prevention Trust Fund Grant for Fillmore Park Improvement Project (Safety Improvements) approved by the Board of Commissioners of Hudson County at a public hearing held on August 8, 2024, is hereby appropriated for improvements to Filmore Park and including all work and materials necessary therefor and incidental thereto

Section 6. The capital budget or temporary capital budget, as applicable, of the Town is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. In the event of any such inconsistency and amendment, the resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget or temporary capital budget, as applicable, and capital program as approved by the Director of the Division of Local Government Services is on file with the Town Clerk and is available there for public inspection.

Section 7. This ordinance shall take effect in accordance with applicable law.
